

Regulations of the Runners for Ukraine (hereinafter referred to as: "Run")

I. ORGANISER

- 1.1. The organizer of the Event is Sport Evolution Group Sp. z o.o., Jana Kochanowskiego 12/23, 01-964 Warszawa, registered in the District Court for the capital city of Warsaw, XIII Wydział Gospodarczy Krajowego Rejestru Sądowego, KRS 0000779253, NIP: 1231431002, REGON: 382960037, **address for correspondence ul. Janki, ul. Falencka 1B, 05-090 Raszyn**, (hereinafter referred to as the "Organizer").

II. DATE

- 2.1. The run will take place between 2 March and 31 March 2022 over a distance of 5 km.

III. PARTICIPATION

- 3.1. A person who has correctly registered for the Race through the SlotMarekt.pl portal and has registered and joined the Race, on the JustMove platform, may participate in the Race.
- 3.2. To participate in the Run, you must have a free account on the JustMove app.
- 3.3. All technical information about the application and the connection between the application and the mobile app can be found on the JustMove platform.
- 3.4. The organiser does not provide accident insurance for the runners.

IV. REGISTRATION

- 4.1. Registrations will be accepted online between 2 March from 18:00 and 31 March 2022 until 23:59.
- 4.2. The registration is considered when the application form is correctly completed and when the payment of the entry fee is paid in the amount specified in these regulations.
- 4.3. The confirmation of successful registration is:
 - 4.3.1. confirmation of registration for the event from SlotMarket.pl (confirmation from the email address contact@slotmarket.pl);
 - 4.3.2. payment confirmation from DotPay (confirmation from email address transakcje@dotpay.pl);
 - 4.3.3. information about registration in the Registration History on the SlotMarket.pl in user account (status: "Registered").

V. ENTRY FEE

- 5.1. The participation fee for the Run is PLN 20.
- 5.2. All proceeds from entry fees will be donated to Polish Humanitarian Action to help war refugees from Ukraine.
- 5.3. The entry fee should be paid via the DotPay transaction service. All data provided in payments are entered on a secure encrypted page.

- 5.4. The fee must be paid upon registration, otherwise the application will be canceled.
- 5.5. The Organizer and the SlotMarket.pl platform will not issue an invoice for the run.
- 5.6. Once paid the entry fee is not refundable.

VI. PROTECTION OF PERSONAL INFORMATION

- 6.1. Personal data controller of runners is Sport Evolution Group Sp. z o.o., Jana Kochanowskiego street 12/23, 01-964 Warsaw, daneosobowe@sportevoolution.pl.
- 6.2. Personal data of participants of Run will be processed for the purposes of organizing and carrying out Run, to select the winner and to award, release, receive the prize and other activities related to the economic activity and will not be shared with other customers.
- 6.3. The participant has a right to access his/her data and correct them. Providing personal data and consent to their processing is optional, but necessary to achieve the said objectives. Failure to provide data or lack of consent to their processing prevents participation in the event. Please be advised that your consent may be revoked at any time.
- 6.4. Processing of participants data, in connection with participation in the event, includes publication of name, surname, year of birth, club participant with the name of the town in which he resides - in every way in which the project will be published.
- 6.5. All information concerning participants obtained by the Organizer and included in the registration form will be recorded in electronic way and in each case they will be used pursuant to in accordance with the applicable law.
- 6.6. The organizer reserves the right to carry out interviews with each of the participants, take photos and film them for advertising, promotional purposes, use on the Internet or in radio and TV broadcasts and for other commercial purposes.
- 6.7. The Organizer reserves the right to use, without compensation, all photographs, films, interviews, and voice recordings introducing the Event participants. These materials may be used by the Organizer in the form of CD-ROMs, DVDs, catalogues, internet sites, newspapers, and exhibition stands, as well for promotional-commercial purposes concerning the Events run by the organizers.
- 6.8. The data retention period shall be
 - 6.8.1. For data processed for the purpose of asserting possible legal claims - until the claim is time-barred or the proceedings related to the claim are concluded.
 - 6.8.2. For data processed for the purpose of documenting and communicating activities, not more than 5 years from the date of the documented event, unless the data are processed for archiving purposes in the public interest.
 - 6.8.3. For data processed to ensure the security of networks and information systems - not more than 5 years from the date of registration.
 - 6.8.4. For data processed on the basis of the athlete's agreement - until that agreement is withdrawn.
- 6.9. In order to withdraw your consent to the processing of your personal data, you must complete the application form on <https://slotmarket.pl/document/polityka-prywatnosci> and send it to contact@slotmarket.pl.

VII. COMPLAINTS

- 7.1. Complaints concerning matters related to the Run shall be submitted in writing with justification to the Organizer's correspondence address, with the note "Runners for Ukraine - Complaint", within 7 days from the date of the event - directly or by registered mail (the date of the postmark is decisive) or to the address: contact@slotmarket.pl, with the note "Runners for Ukraine - Complaint".
- 7.2. Complaints sent after the deadline in point 7.1. will not be considered.
- 7.3. Complaints about race will be considered by Organizer within 60 days of their receipt.
- 7.4. The Organizer's decision on complaints about race will be final. The above does not limit the Consumer's rights to pursue their claims under mandatory provisions of law before common courts.

VIII. COMPLAINTS PROCEDURE

- 8.1. All participants in the Run are bound by these Rules.
- 8.2. Each participant is obliged to become familiar with the regulations
- 8.3. Ignorance of the Run Regulations does not exempt the Runner from the rules specified by the Organiser in these Regulations.
- 8.4. The Participant declares that he/she is fit to take part in the Run, that he/she is not aware of any health reasons excluding him/her from taking part in the Run and that he/she takes part at his/her own risk and acknowledges that participation in the Run involves physical effort and entails a natural risk of accident, bodily injury and physical trauma (including death) as well as property damage and losses. In addition, there may be other risk factors associated with participation in the Run that are not foreseeable at this time. The participant has considered and assessed the extent and nature of the risks involved in taking part in the Run, takes part voluntarily and solely at his/her own risk.
- 8.5. The organiser is not responsible for the continuity and speed of data transmission or for technical conditions on the part of the competitor.
- 8.6. In matters not covered by these Terms and Conditions, the Organiser shall decide on the basis of applicable law. The above does not limit the right to court in case of dispute.
